

**Hadley Arkes** is the Edward Ney Professor of American Institutions at Amherst College. He is the author of *Bureaucracy, the Marshall Plan, and the National Interest* (1972), *The Philosopher in the City* (1981), *First Things* (1986), *Beyond the Constitution* (1990), and *The Return of George Sutherland* (1994) and *Natural Rights and the Right to Choose* (2002). His articles have appeared in professional journals, but apart from his writing in more scholarly formats, he has become known to a wider audience through his writings in the *Wall Street Journal*, the *Washington Post*, the *Weekly Standard*, and *National Review*, where he has been a contributing editor. Professor Arkes has also been a contributor to *First Things*, a journal that took its name from his book of that title. He is the founder of Amherst's Committee for the American Founding, a group of alumni and students seeking to preserve the doctrines of "natural rights" taught by the American Founders and Lincoln.

**Gerard V. Bradley** is professor of law at the University of Notre Dame, where he edits (with John Finnis) *The American Journal of Jurisprudence*. A *summa cum laude* graduate of Cornell Law School, Bradley taught at the University of Illinois College of Law for nine years before moving to Notre Dame in 1992. His scholarly publications have focused on the constitutional law of church and state, starting with his 1987 study of nonestablishment during the Founding era—*Church-State Relationships in America*. Bradley's current research project focuses on the development of secularism in American constitutional law since World War II.

Professor Bradley has served as president of the Fellowship of Catholic Scholars, chair of the Federalist Society Religious Liberties Practice Group, and vice-president of the American Public Philosophy Institute, and a member of the consulting board of the James Madison Society.

**Christopher L. Eisgruber** is Princeton University's provost and Laurance S. Rockefeller Professor of Public Affairs in the Woodrow Wilson School and the University Center for Human Values. The former director of Princeton's Program in Law and Public Affairs, he is the author of *Constitutional Self-Government* (2001) and of numerous articles in books and academic journals. His coauthored book with Professor Lawrence G. Sager focuses on problems of religious liberty and is entitled *The Vulnerability of Conscience*. Before joining the Princeton faculty in 2001, he clerked for Judge Patrick Higginbotham of the United States Court of Appeals for the Fifth Circuit and for Justice John Paul Stevens of the Supreme Court of the United States, and then served for eleven years on the faculty of the New York University School of Law.

Professor Eisgruber received an A.B. *magna cum laude* in Physics from Princeton, an M. Litt. in Politics from Oxford University, and a J.D. from the University of Chicago Law School. He is a member of the American Law Institute.

**John M. Finnis** is professor of law and legal philosophy at the Oxford University, and the Biolchini Family Professor at Notre Dame Law School. He has taught law and political philosophy at Oxford for several decades, and is a Fellow of the British Academy. His books include *Natural Law and Natural Rights* (1980/15th impression 2002) and *Aquinas: Moral, Political and Legal Theory* (1998).

**William A. Galston** is the Saul Stern Professor at the University of Maryland's School of Public Affairs, director of the Institute for Philosophy and Public Policy, and founding director of CIRCLE (the Center for Information and Research on Civic Learning and Engagement). He is the author of six books and over 100 articles in the fields of political philosophy, American politics, and public policy. His most recent book is *Liberal Pluralism* (2002) and *The Practice of Liberal Pluralism* is forthcoming in fall 2004.

Professor Galston served as deputy assistant to President Clinton for domestic policy, as senior advisor to Albert Gore, Jr. during his 1988 presidential campaign, as issues director for Walter Mondale's presidential campaign (1982-1984), and as chief speechwriter for John Anderson's presidential campaign (1980).

**Robert P. George** is the director of the James Madison Program in American Ideals and Institutions and Princeton's McCormick Professor of Jurisprudence. He is the author of *Making Men Moral: Civil Liberties and Public Morality* (1993) and *In Defense of Natural Law* (1999). His most recent book is *The Clash of Orthodoxies*. He is editor of *Natural Law Theory: Contemporary Essays* (1992), *The Autonomy of Law: Essays on Legal Positivism* (1996), *Natural Law, Liberalism, and Morality* (1996), and *Great Cases in Constitutional Law* (2000) and co-editor of *Constitutional Politics: Essays on Constitution Making, Maintenance, and Change* (2001). Professor George's articles and review essays have appeared in the *Harvard Law Review*, the *Yale Law Journal*, the *Columbia Law Review*, the *University of Chicago Law Review*, the *Review of Politics*, the *Review of Metaphysics*, and the *American Journal of Jurisprudence*. He has also written for the *Wall Street Journal*, the *Washington Post*, *First Things*, *National Review*, *Touchstone*, the *Boston Review*, and the *Times Literary Supplement*. He is general editor of New Forum Books, a Princeton University Press series of interdisciplinary works in law, culture, and politics.

Professor George currently serves on the President's Council on Bioethics, and from 1993-98 he served as a presidential appointee to the United States Commission on Civil Rights.

**Eddie S. Glaude, Jr.** is associate professor of religion and African American studies at Princeton University. Prior to his appointment at Princeton, he taught at Bowdoin College and Amherst College in African American Studies and Religion. He received his B.A. from Morehouse College, and his M.A. and Ph.D. from Princeton University.

He is the author of *Exodus! Religion, Race, and Nation in Early 19th Century Black America* and the recipient of the Modern Language Association's William Sanders Scarborough Book Prize for outstanding scholarly study of black cultural life and/or literature. Professor Glaude is also editor of *Is it Nation Time? Contemporary Essays on Black Power and Black Nationalism*, and co-editor with Cornel West of *African American Religious Thought: An Anthology*.

**Eric Gregory** is assistant professor of religion at Princeton and a fellow at the Erasmus Institute at the University of Notre Dame. His teaching and research interests include religious and philosophical ethics, theology, political theory, and the role of religion in public life. A graduate of Harvard College, he did graduate studies in theology as a Rhodes Scholar at Oxford and received his doctorate in religious studies from Yale University. He is completing a book tentatively titled, *Politics and the Order of Love: Modern Variations on Augustinian Themes*. His article, "Augustine and Arendt on Love: New Dimensions for Religion and Liberalism Debates," appears in the 2001 *Journal of the Society of Christian Ethics*.

**Mary Ann Glendon** is the Learned Hand Professor of Law at Harvard University. Her work focuses on human rights, comparative law, constitutional law, and legal theory. She is the author of nine books. Her most recent book is *A World Made New: Eleanor Roosevelt and the Universal Declaration of Human Rights*.

Professor Glendon taught at Boston College Law School, the University of Chicago Law School, and the Gregorian University in Rome. She received her B.A., J.D., and master of comparative law degrees from the University of Chicago. Professor Glendon currently serves on the President's Council on Bioethics, is a member of the American Academy of Arts and Sciences, and the International Academy of Comparative Law, and is a past president of the UNESCO-sponsored International Association of Legal Science. By appointment of Pope John Paul II, she is president of the Pontifical Academy of Social Sciences.

**Philip Hamburger** is the John P. Wilson Professor at the University of Chicago Law School, where he teaches constitutional law, religious liberty, and legal history. He received a B.A. from Princeton and a J.D. from Yale Law School. Before joining the University of Chicago faculty, he practiced law in Philadelphia and taught law at the University of Connecticut, the University of Virginia, George Washington University, and Northwestern University. His scholarship focuses on constitutional law and legal history. He recently published *Separation of Church and State* (2002), and currently is writing on judicial review.

**Jeanne Heffernan** is a member of the Department of Humanities and Augustinian Traditions at Villanova University. She received an M.A. and a Ph.D. in Government from the University of Notre Dame, where she served as the associate director of the Erasmus Institute, a center dedicated to research in the intellectual traditions of the Abrahamic faiths. She was also a visiting research fellow at the Ethics and Public Policy Center, where she contributed to the Catholic Studies Project, working on a primer on Catholic moral and social thought. Prior to joining the faculty at Villanova, she was a member of the faculty of Pepperdine University, teaching courses on political theory, American government, public policy, and Christian political thought.

Professor Heffernan has published articles on Christianity and politics, democratic theory, and the relationship between faith and learning. She is currently editing a book on Catholic and Protestant contributions to the discussion of civil society.

**Byron R. Johnson** is Distinguished Professor of Sociology and director of the Center for Religious Inquiry Across the Disciplines (CRIAD) at Baylor University. He is also a senior fellow at the Witherspoon Institute in Princeton, New Jersey. He formerly directed the Center for Research on Religion and Urban Civil Society (CRRUCS) at the University of Pennsylvania, and was a lecturer in the Politics Department at Princeton University. Professor Johnson's research focuses on quantifying the effectiveness of faith-based organizations to confront various social problems. Recent publications have examined the efficacy of the "faith factor" in reducing crime and delinquency among at-risk youth in urban communities. He has conducted a number of studies examining the impact of faith-based programs on recidivism reduction and prisoner reentry and is currently conducting a study of Teen Challenge, a faith-based drug treatment program.

**Stephen J. Macedo** is the director of Princeton University's Center for Human Values and the Laurance S. Rockefeller Professor of Politics. His publications range across the fields of political theory, ethics, American constitutionalism, and public policy, with an emphasis on liberalism and its critics, and the roles of schools, civil society, and public policy in shaping citizens. He is author of *Diversity and Distrust: Civic Education in a Multicultural Democracy* (2000);

*Liberal Virtues: Citizenship, Virtue, and Community in Liberal Constitutionalism* (1990); and *The New Right v. The Constitution* (1987). His essay, "Homosexuality and the Conservative Mind," (*Georgetown Law Review*, December 1995), won the Fred L. Berger prize of the American Philosophical Association. Among his edited volumes are *Reassessing the Sixties: Debating the Political and Cultural Legacy* (1997), *Deliberative Politics: Essays on Democracy and Disagreement* (1999), and *Moral and Political Education, NOMOS XLIII*, co-edited with Yael Tamir, (2001). He is co-editor, with Walter F. Murphy, James E. Fleming, and Sotirios A. Barber of *American Constitutional Interpretation*, 3rd ed. (2002).

**Walter A. McDougall** is the Alloy-Ansin Professor of History and International Relations at the University of Pennsylvania, where he also directs the undergraduate international relations program. He is the author of seven books, including the Pulitzer Prize-winning *The Heavens and the Earth: A Political History of the Space Age* (1985), *Let the Sea Make a Noise: A History of the North Pacific From Magellan to MacArthur* (1992), *Promised Land, Crusader State: The American Encounter With the World Since 1776* (1997), and *Freedom Just Around the Corner: A New American History 1585-1828* (2004).

Professor McDougall has a B.A. from Amherst College and a Ph.D. from the University of Chicago. He taught at the University of California, Berkeley, prior to taking his current position at the University of Pennsylvania. He is also affiliated with Philadelphia's Foreign Policy Research Institute, where he edits its journal *Orbis* and serves as a senior fellow. In that capacity he has written widely on contemporary issues of American foreign policy and the "culture wars" in American schools.

**George McKenna** is professor emeritus and former chair of the Department of Political Science at City College of the City University of New York. He has written for a number of publications, including *The Atlantic Monthly*, *The Journal of Politics*, *History of Political Thought*, and *First Things*. Among the books of which he is either author, editor, or co-editor are *Guide to the Constitution: That Delicate Balance* (1984), *The Drama of Democracy* (1998), and *Taking Sides: Clashing Views on Controversial Political Issues*, now in its 14th edition. He is presently writing a book on the Puritan origins of American patriotism for the Yale University Press.

**Richard John Neuhaus** is one of the foremost authorities on the role of religion in the contemporary world and president of The Institute on Religion and Public Life, a nonpartisan inter-religious research and education institute in New York City. He is editor-in-chief of the institute's publication, *First Things: A Monthly Journal of Religion and Public Life*. He is the author of *Freedom for Ministry*, *The Naked Public Square: Religion and Democracy in America*, *The Catholic Moment: The Paradox of the Church in the Postmodern World*, and co-author, with Rabbi Leon Klenicki, *Believing Today: Jew and Christian in Conversation*.

He has held presidential appointments in the Carter, Reagan, and first Bush administration, and has played a leadership role in organizations dealing with civil rights and international justice.

**Michael Pakaluk** is professor at Clark University. He writes extensively on the history of philosophy. He has published in specialist journals in ancient philosophy, medieval philosophy, Scottish philosophy, and early analytic philosophy. He is the author of *Other Selves: Philosophers on Friendship*, the Clarendon Aristotle volume on *Nicomachean Ethics* VIII and IX; and, most recently, *Aristotle's Ethics: An Introduction*. He is the director of the Boston Area Colloquium in Ancient Philosophy. Pakaluk earned his A.B. and Ph.D. from Harvard University and an M. Litt. from the University of Edinburgh.

**Arthur M. Schlesinger, Jr.**, who is remembered by many Americans for his years as special assistant to President John F. Kennedy, is known for his government and public service, his academic scholarship, and his numerous publications. He has twice won the Pulitzer Prize and the National Book Award; his government service includes a stint as special assistant in Paris to Averill Harriman during the first months of the Marshall Plan and as a member of Governor Adlai Stevenson's campaign. He is the author of 16 books including the bestsellers *The Imperial Presidency*, *Robert Kennedy and His Times*, *The Cycles of American History*, and *A Thousand Days: John F. Kennedy in the White House*.

Schlesinger was educated at Phillips Exeter Academy and Harvard University. He was a Henry Fellow at Peterhouse, Cambridge University, in 1938-39 and a member of the Society of Fellows at Harvard from 1939 to 1942.

After serving in World War II, in the Office of War Information in the Office of Strategic Services, he took a position in the department of history at Harvard University. He left Harvard University to become the Albert Schweitzer Professor in the Humanities at the Graduate School of the City University of New York. Schlesinger has served as president of the American Academy of Arts and Letters, co-chair of the Franklin and Eleanor Roosevelt Institute, a member of the advisory board of the Arthur and Elizabeth Schlesinger Library on the History of Women in America (named for his parents), and a trustee of the Twentieth Century Fund.

**Rogers M. Smith** is the Christopher H. Browne Distinguished Professor and Chair of Political Science at the University of Pennsylvania. He teaches American constitutional law and American political thought, with special interests in issues of citizenship and racial, gender, and class inequalities. He has published over 90 essays in academic journals, edited volumes and public interest publications, including the *American Political Science Review*, the *Western Political Quarterly*, *Studies in American Political Development*, *Daedalus*, *Social Research*, *Yale Law Journal*, the *American Prospect*, and the *Nation*. He is author or co-author of five books: *Stories of Peoplehood: The Politics and Morals of Political Memberships* (2003); *The Unsteady March: The Rise and Decline of Racial Equality in America* (with Philip A. Klinkner, 1999); *Civic Ideals: Conflicting Visions of Citizenship in U.S. History* (1997), which was a finalist for the 1998 Pulitzer Prize in history; *Citizenship without Consent: The Illegal Alien in the American Polity* (with Peter H. Schuck, 1985); and *Liberalism and American Constitutional Law* (1985, rev. ed.1990).

**James R. Stoner, Jr.**, is professor of political science at Louisiana State University. He is the author of *Common-Law Liberty: Rethinking American Constitutionalism* (2003), and *Common Law and Liberal Theory: Coke, Hobbes, and the Origins of American Constitutionalism* (1992), as well as a number of articles and essays. In 2002-03 he was a visiting fellow in the James Madison Program in American Ideals and Institutions at Princeton University. He is a member of the James Madison Society, and of the National Council on the Humanities. He is currently at work on a book tentatively titled *Resisting Judicial Supremacy*, with Richard Morgan of Bowdoin College. He is also working on a study of the political and constitutional thought of St. Thomas More.

**Joseph H. H. Weiler** is University Professor at New York University. He serves as the Joseph Straus Professor and European Union Jean Monnet Chair of New York University's School of Law, is chairman of its Global Law School Program, and director of the Jean Monnet Center for International and Regional Economic Law and Justice. He is also professor at the College of Europe, Bruges, honorary professor at University College London and a member of the Department of Political Science at the University of Copenhagen. He has previously been professor of law at the European University Institute in Florence, at the Michigan Law School and the Manley Hudson Professor of Law and Jean Monnet Chair at Harvard. His recent publications include *Un Europa Cristiana* (2003), *Integration in an Expanding European Union* (2003, with I. Begg and J. Peterson) *The European Court of Justice* (2001, with G. de Burca) *The EU, the WTO and the NAFTA* (2000), *The Constitution of Europe* (1998), and a novella, *Der Fall Steinmann* (2000). A fellow of the American Academy of Arts and Sciences, he earned his B.A. with First Class Honors at Sussex, his LL.B and LL.M at Cambridge, and his Ph.D at the EUI. He is a

founding editor of the *European Journal of International Law*, of the *European Law Journal* and of the *World Trade Review*.

**Bradford P. Wilson** is associate director of the James Madison Program in American Ideals and Institutions and lecturer in politics at Princeton University. He is editor of *Academic Questions*, the quarterly journal of the National Association of Scholars, and has authored or edited four books in American constitutional studies. He was a Fulbright senior scholar at Moscow State University in 1994-95, and served three years as research associate to two chief justices of the United States, Warren E. Burger and William H. Rehnquist. His Ph.D. is from The Catholic University of America.

**Christopher Wolfe** is professor of political science at Marquette University. His main area of research and teaching is in Constitutional law and American political thought. He is the author of *The Rise of Modern Judicial Review* (1986; revised edition, 1994), *Judicial Activism: Bulwark of Liberty or Precarious Security?* (revised edition, 1997), and *How to Read the Constitution* (1996). His current project, in the area of liberal political theory and legal philosophy, is a book on A Natural Law Liberalism.

Professor Wolfe is the founder and president of the American Public Philosophy Institute, a group of scholars from various disciplines that seeks to bring natural law theory to bear on contemporary scholarly discussions.
