



Roger E. Hernandez writes a nationally syndicated column distributed by King Features Syndicate to some 40 newspapers and teaches writing at Rutgers University and the New Jersey Institute of Technology. He is the co-author of *Cubans in America: A Vibrant History of a People in Exile*, and author of *Immigration*, part of the series “Gallup Major Trends and Events: The Pulse of Our Nation 1900 to the Present.” He has written articles for *The New York Times*, *New Jersey Monthly*, *Washington Journalism Review*, the Spanish and French language editions of *Reader’s Digest*, *Hispanic Business* and *Vista*. Hernandez is now developing a series for middle-school readers on the history of Hispanics in the U.S.

Douglas S. Massey is Henry G. Bryant Professor of Sociology and Public Affairs at Princeton University. He is a member of the National Academy of Sciences, the American Academy of Arts and Sciences, the American Philosophical Society, the Committee on National Statistics of the National Research Council, the Immigration Advisory Board of the Russell Sage Foundation, and is the current president of the American Academy of Political and Social Science. He is co-editor of the *Annual Review of Sociology*, author of *Return of the L-Word: A Liberal Vision for the New Century* and *Strangers in a Strange Land: Humans in an Urbanizing World*, and editor of the forthcoming *New Faces in New Places: The Changing Geography of American Immigration*.

Peter H. Schuck is the Simeon E. Baldwin Professor of Law at Yale Law School. His books include *Targeting in Social Programs: Avoiding Bad Bets*, *Removing Bad Apples*, *Meditations of a Militant Moderate: Cool Views on Hot Topics*, *Immigration Stories*; *Foundations of Administrative Law*, *Diversity in America: Keeping*

Government at a Safe Distance, and *The Limits of Law: Essays on Democratic Governance*. He is co-editor, with James Q. Wilson, of the forthcoming *Understanding America*. He is a member of the American Law Institute’s advisory committee for the Restatement of Torts (Third), Basic Principles, and a contributing editor to *The American Lawyer*.

Carol M. Swain is Professor of Political Science and of Law at Vanderbilt University. Her book, *Black Faces, Black Interests: The Representation African Americans in Congress*, was named one of the seven outstanding academic books of 1994 by Library Choice Journal, received the 1994 Woodrow Wilson Prize for the best book published in the United States on government, politics, or international affairs, was awarded the Hardeman Prize for best scholarly work on Congress during 1994-95, and was co-winner of the Key Award for the best book published on southern politics. Swain’s more recent books are *Debating Immigration* (ed.), *The New White Nationalism in America: Its Challenge to Integration*, and *Contemporary Voices of White Nationalism* (with Russ Nieli). Swain is a member of the Tennessee Advisory Committee to the U.S. Civil Rights Commission.

Robert J. Wuthnow is Andlinger Professor of Sociology at Princeton University, Chair of the Department of Sociology, and Director of the Center for the Study of Religion. He is the author of numerous books including *Creative Spirituality: The Way of the Artist*, *All In Sync: How Music and Art Are Revitalizing American Religion*, *Saving America? Faith-Based Services and the Future of Civil Society*, *America and the Challenges of Religious Diversity*, *American Mythos: Why Our Best Efforts to Be a Better Nation Fall Short*, and *After the Baby Boomers: How Twenty- and Thirty-Somethings Are Shaping the Future of American Religion*. Currently he is directing a Lilly-funded project on the global reach of Christian organizations in the United States.
