Akhil Reed Amar is the Southmayd Professor of Law and Political Science at Yale University and Yale Law School. He served as Editor of the *Yale Law Journal* and went on to clerk for Judge Stephen Breyer, U.S. Court of Appeals, First Circuit. He is co-editor, along with Dean Paul Brest and Professors Sanford Levinson, Jack Balkin, and Reva Siegel, of a leading constitutional law casebook, *Processes of Constitutional Decisionmaking*. He is also the author of several books, including *The Constitution and Criminal Procedure: First Principles*, *The Bill of Rights: Creation and Reconstruction*, and most recently, *America's Constitution: A Biography*. He holds a J.D. from Yale Law School.

Charles J. Cooper is a founding member and chairman of Cooper & Kirk, PLLC. Named by the *National Law Journal* as one of the 10 best civil litigators in Washington, he has made several appearances before the Supreme Court of the United States. He clerked for Judge Paul Roney of the U.S. Court of Appeals for the Eleventh Circuit and for Chief Justice William H. Rehnquist. He then joined the Civil Rights Division of the U.S. Department of Justice and was appointed by President Reagan to the position of Assistant Attorney General for the Office of Legal Counsel. He was appointed by Chief Justice Rehnquist to the Standing Committee on Rules of Practice and Procedure of the Judicial Conference of the United States. He is a member of the American Law Institute and the American Academy of Appellate Lawyers. He holds a J.D. from the University of Alabama Law School.

Donald L. Drakeman is Lecturer in the Department of Politics at Princeton University. He is Chairman of the Advisory Council of the James Madison Program in American Ideals and Institutions and co-chairman of the Advisory Council for the Department of Religion. He is the author of *Church-State Constitutional Issues: Making Sense of the Establishment Clause* and co-editor of *Church and State in American History*. A trustee of Drew University, he has worked as a corporate lawyer, business executive and venture capitalist. He has served as counsel *pro bono* for a coalition of Christian and Jewish organizations acting as *amici curiae* in First Amendment litigation. He holds a J.D. from Columbia Law School and a Ph.D. from Princeton University.

Richard W. Garnett is John Cardinal O'Hara, C.S.C. Professor of Law at Notre Dame Law School. He served as Senior Editor of the *Yale Law Journal* and as Editor of the *Yale Journal of Law & the Humanities*. He clerked for Chief Judge Richard S. Arnold of the U. S. Court of Appeals for the Eighth Circuit, and then for Chief Justice William H. Rehnquist. Before entering academia he practiced law for two years in Washington, D.C. At Notre Dame, he teaches courses on criminal law, criminal procedure, First Amendment law, and the death penalty. He holds a J.D. from Yale Law School.



Robert P. George is McCormick Professor of Jurisprudence and founding Director of the James Madison Program at Princeton University. He serves on the President’s Council on Bioethics, formerly served as a presidential appointee to the United States Commission on Civil Rights, and was a Judicial Fellow at the Supreme Court of the United States, where he received the Justice Tom C. Clark Award. He is a recipient of the 2005 Bradley Prize for Intellectual and Civic Achievement and the Philip Merrill Award for Outstanding Contributions to Liberal Arts Education. His books include *In Defense of Natural Law*, *Making Men Moral: Civil Liberties and Public Morality*, *The Clash of Orthodoxies: Law, Religion and Morality in Crisis*, and, most recently, *Body-Self Dualism in Contemporary Ethics and Politics* (with Patrick Lee) and *Embryo: A Defense of Human Life* (with Christopher Tollefsen). He holds a J.D. from Harvard Law School and D.Phil. from Oxford University.

Kent Greenawalt is University Professor at Columbia Law School. He served as Editor-in-Chief of the *Columbia Law Review* and clerked for U.S. Supreme Court Justice John M. Harlan. Greenawalt is a former United States Deputy Solicitor General, served on the Civil Rights Committee of the Association of the Bar of the City of New York, serves as a member of the Due Process Committee of the American Civil Liberties Union, and is a Fellow of the American Council of Learned Societies. He is author of more than half a dozen books. He is a Fellow of the American Academy of Arts and Sciences and former President of the American Society for Political and Legal Philosophy. Greenawalt holds an LL.B. from Columbia Law School.

R. Shep Melnick is the Thomas P. O’Neill, Jr. Professor of American Politics at Boston College and Co-chair of the Harvard Program on Constitutional Government. He is the author of two books published by the Brookings Institution, *Between the Lines: Interpreting Welfare Rights and Regulation and the Courts: The Case of the Clean Air Act*. He is currently working on a book on the Rehnquist Court. Melnick has also been a Research Associate at Brookings, President of the New England Political Science Association, and an elected member of the New Hampshire House of Representatives. He holds a Ph.D. from Harvard University.

Robert F. Nagel is the Ira C. Rothgerber, Jr. Professor of Constitutional Law at the University of Colorado Law School. He is a former Deputy Attorney General of the Commonwealth of Pennsylvania. He is the author of *Constitutional Cultures: The Mentality and Consequences of Judicial Review*, *Judicial Power and American Character: Censoring Ourselves in an Anxious Age*, and *The Implosion of American Federalism*, and is editor of *Intellect and Craft: The Contributions of Justice Hans Linde to American Constitutionalism*. His articles have appeared in the *New Republic*, *Washington Monthly*, *Public Interest*, *Weekly Standard*, *First Things*, and the *Wall Street Journal*. Nagel is a Fellow of the American Academy of Arts & Sciences. He holds a J.D. from Yale Law School.



Kim L. Scheppele is Laurance S. Rockefeller Professor of Public Affairs and Director of the Program in Law and Public Affairs at Princeton University. Since 9/11, she has researched the effects of the international “war on terror” on constitutional protections around the world. Her book-in-progress, *The International State of Emergency*, explores the creation of international security law through UN Security Council resolutions and examines the effect that apparent compliance with these resolutions has had on constitutional integrity. Articles from this project have appeared in the *Fordham Law Review*, the *Georgia Law Review*, *I-Con*, the *Loyola Law Review* and the *University of Pennsylvania Journal of Constitutional Law*. She holds a Ph.D. from the University of Chicago.

Stephen J. Schulhofer is the Robert B. McKay Professor of Law at New York University Law School. He has published six books and over fifty scholarly articles. His most recent book, *Rethinking the Patriot Act*, written for The Century Foundation’s Project on Homeland Security, attracted wide attention as a careful and balanced critique of measures associated with the “war on terror.” Schulhofer was the Developments and Supreme Court editor of the *Harvard Law Review* and then clerked for two years for U.S. Supreme Court Justice Hugo Black. He practiced law for several years with the firm Coudert Frères in France before entering academia. He holds a J.D. from Harvard Law School.

Stephen F. Smith is John V. Ray Professor of Law at the University of Virginia Law School. He served as Articles Editor on the *Virginia Law Review*. He is a member of the Order of the Coif, the national legal honors society, as well as The Raven Society, the University of Virginia’s honors society. He clerked for Supreme Court Justice Clarence Thomas and, after a year in the Chambers of Judge David B. Sentelle of the U.S. Court of Appeals for the District of Columbia Circuit, he entered private practice in Washington, DC. His articles have appeared in a number of law reviews, including the *Virginia Law Review* and the *Texas Law Review*. He serves as the Law School’s liaison to the FBI’s National Academy and as faculty advisor to the National Criminal Justice Command College. He holds a J.D. from the University of Virginia Law School.

Keith E. Whittington is William Nelson Cromwell Professor of Politics at Princeton University. He is the author of *Constitutional Construction: Divided Powers and Constitutional Meaning*, *Constitutional Interpretation: Textual Meaning, Original Intent, and Judicial Review*, and *Political Foundations of Judicial Supremacy: The Presidency, the Supreme Court, and Constitutional Leadership in U.S. History*. He is editor (with Neal Devins) of *Congress and the Constitution* and editor (with R. Daniel Kelemen and Gregory A. Caldeira) of the forthcoming *Oxford Handbook of Law and Politics*. Whittington has been a John M. Olin Foundation Faculty Fellow, American Council of Learned Societies Junior Faculty Fellow, and a Visiting Scholar at the Social Philosophy and Policy Center. He holds a Ph.D. from Yale University.



Bradford P. Wilson is Associate Director of the James Madison Program in American Ideals and Institutions at Princeton University. His interests include American constitutional law, American political thought, and Western political thought. He is the author of *Enforcing the Fourth Amendment: A Jurisprudential History* and co-editor of three books: *American Political Parties & Constitutional Politics*, *Separation of Powers and Good Government*, and *The Supreme Court and American Constitutionalism*. Wilson is President of the Association for the Study of Free Institutions, was a Fulbright Senior Scholar at Moscow State University in 1994-95, and served three years as Research Associate to two Chief Justices of the United States, Warren E. Burger and William H. Rehnquist. From 1996 to 2004, he served as Executive Director of the National Association of Scholars. He holds a Ph.D. from The Catholic University of America.
