William B. Allen is the Ann and Herbert W. Vaughan Visiting Fellow in the James Madison Program in American Ideals and Institutions at Princeton University. He is on leave from Michigan State University, where he is Professor of Political Science. Professor Allen has served as a member of the National Council for the Humanities and as member and chair of the United States Commission on Civil Rights. He was formerly Director of the State Council of Higher Education for Virginia (while on leave from MSU), and Dean and Professor at James Madison College, Michigan State University. Recognized for excellence in liberal education on the 1997 Templeton Honor Roll (individually and institutionally), Professor Allen has been a Fulbright Fellow and a Kellogg National Fellow, and he received the international Prix Montesquieu. His most recent book is *Habits of Mind: Fostering Access and Excellence in Higher Education* (with Carol Allen; Transaction Publishers, 2003). He received his Ph.D. from the Claremont Graduate School.

William J. Bennett is host of the nationally broadcast radio show, “Bill Bennett’s Morning in America.” He is the Washington Fellow of the Claremont Institute, is Chairman of Americans for Victory over Terrorism, and is a regular contributor to CNN. Dr. Bennett served as Chairman of the National Endowment for the Humanities and Secretary of Education under President Reagan and as Director of the Office of National Drug Control Policy under President George H. W. Bush. He has written or edited 16 books and recently published the first of a two-volume history of the United States entitled *America: The Last Best Hope*. The second volume will be released in the spring of 2007. Dr.



Bennett holds a J.D. from Harvard Law School and a Ph.D. from the University of Texas.

James W. Ceaser is Professor of Politics at the University of Virginia. He has also held visiting professorships at the University of Florence, the University of Basel, Oxford University, the University of Bordeaux, and the University of Rennes. He is the author of several books on American politics and political thought, including: *Presidential Selection*; *Reforming the Reforms*; *Liberal Democracy and Political Science*; *Reconstructing America*; and, *Nature and History in American Political Development*. Professor Ceaser is a frequent contributor to the popular press, and often comments on American Politics for the Voice of America. In 1996 he was awarded “The Joint Meritorious Unit Award for Total Engagement in the Creation of the George C. Marshall Center for European Security Studies” by the United States Army. He received his Ph.D. from Harvard University.

Eric Cohen is Director of the Bioethics and American Democracy Program at the Ethics and Public Policy Center. He is also the editor of *The New Atlantis*, EPPC’s quarterly journal about the ethical, political, and social implications of technological advancement. His essays and articles have appeared in the *Washington Post*, the *Wall Street Journal*, the *Los Angeles Times*, *USA Today*, *The Weekly Standard*, *The Public Interest*, *First Things*, and *Commentary*. He is the co-editor (with William Kristol) of *The Future is Now: America Confronts the New Genetics* (Rowman & Littlefield, 2002). He was previously a fellow at the New America Foundation and served as Managing Editor of *The Public Interest*. He also



serves as a senior consultant to the President's Council on Bioethics.

John J. Dilulio, Jr. is Frederick Fox Leadership Professor of Politics, Religion, and Civil Society at the University of Pennsylvania, and a Senior Fellow at the Brookings Institution. He directs the University's Program for Research on Religion and Urban Civil Society, as well as its largest undergraduate leadership program. He served as Assistant to President George W. Bush and first Director of the White House Office of Faith-Based and Community Initiatives. He has developed community-serving programs, now at work in dozens of cities, to mentor children of prisoners; provide literacy training in low-income neighborhoods; reduce youth violence in high-crime police districts; and several others. He has also worked with several television networks, most recently as chief consultant to the PBS production "God and the Inner City." He has written hundreds of articles and essays for both academic and popular audiences and has received numerous awards and honorary degrees. He has authored or co-authored dozens of books including: *American Government: Institutions and Policies* (with James Q. Wilson; and, *Godly Republic* (forthcoming 2007). He received his Ph.D. from Harvard University.

William A. Galston is a Senior Fellow at the Brookings Institution. His research focuses on core questions of American public philosophy. Prior to his appointment at Brookings, he was Saul I. Stern Professor of Civic Engagement and Director of the Institute for Philosophy



and Public Policy at the University of Maryland. In the first two years of President Clinton's administration, he served as the Deputy Assistant to the President for Domestic Policy. He has served as Director of Economic and Social Programs at the Roosevelt Center for American Policy Studies in Washington, D.C., as chief speech writer for John Anderson's National Unity campaign, as issues director for Walter Mondale's presidential campaign and as senior advisor to Albert Gore Jr. during his run for the Democratic presidential nomination in 1991-1992. Dr. Galston served as a founding member of the Board of the National Campaign to Prevent Teen Pregnancy and as chair of the Campaign's Task Force on Religion and Public Values. He is a founding co-editor of *The Responsive Community*. His publications include: *Liberal Purposes: Goods, Virtues, and Diversity in the Liberal State*, and a series of articles on family policy. He received his Ph.D. from University of Chicago.

Robert P. George is McCormick Professor of Jurisprudence and founding Director of the James Madison Program at Princeton University. He serves on the President's Council on Bioethics, formerly served as a presidential appointee to the United States Commission on Civil Rights and was judicial fellow at the Supreme Court of the United States, where he received the Justice Tom C. Clark Award. Professor George is a recipient of the 2005 Bradley Prize for Intellectual and Civic Achievement, the Philip Merrill Award for Outstanding Contributions to Liberal Arts Education, and the Stanley Kelley, Jr. Teaching Award from Princeton's Department of Politics. He is the author of *In Defense of Natural Law, Making Men Moral: Civil Liberties and*



Public Morality, and *The Clash of Orthodoxies: Law, Religion and Morality in Crisis*. Professor George received a J.D. from Harvard Law School and a D.Phil. from Oxford University.

Nathan Glazer is Professor Emeritus of Sociology and Education at Harvard University. He contributed to *The Public Interest's* inaugural issue in 1965, and was a regular contributor throughout its 40-year existence. He replaced Daniel Bell as co-editor, with Irving Kristol, in 1976, and remained co-editor until 2003, when Adam Wolfson took over as editor, and he and Kristol took the titles of Senior Editorial Associates, which they held until the journal published its last issue. Professor Glazer was born and educated in New York City, graduated from the City College of New York, was part of the founding editorial group at *Commentary* in 1945, served as an editor of Doubleday Anchor books and Random House, became professor of sociology at the University of California, Berkeley, from 1963-69, and subsequently became professor of sociology and education at Harvard. His publications include: *American Judaism*; *The Social Basis of American Communism*; *Beyond the Melting Pot* (with Daniel P. Moynihan); *Remembering the Answers*; *Affirmative Action Discrimination*; *Ethnic Dilemmas*; *The Limits of Social Policy*; *We are all multiculturalists Now*; and, the forthcoming *From a Cause to a Style: Modernist Architecture's Encounter with the American City*. He received his Ph.D. from Columbia University.

Kay S. Hymowitz is the William E. Simon Fellow at the Manhattan Institute. She is a contributing editor of *City Journal* and writes extensively on education and childhood



in America. She is the author of *Liberation's Children: Parents and Kids in a Postmodern Age*, and the forthcoming book, *Marriage and Caste in America: Separate and Unequal Families in a Post-Marital Age*. Her articles and essays have appeared in the *New York Times*, the *Washington Post*, the *Wall Street Journal*, the *New Republic*, *New York, Newsday*, *The Public Interest*, *Commentary*, *Dissent*, and *Tikkun*. Dr. Hymowitz received a B.A. magna cum laude with honors in English and American literature from Brandeis University, an M.A. in English literature from Tufts University, and a Masters of Philosophy from Columbia University. Before becoming a full-time freelance writer, she taught English literature and composition at Brooklyn College and Parsons School of Design.

Ken I. Kersch is Assistant Professor of Politics at Princeton University. Professor Kersch serves as a member of the executive committee and a faculty associate in the Department of Politics' James Madison Program in American Ideals and Institutions, and as a faculty associate in the Woodrow Wilson School's Law and Public Affairs Program. His publications include: *Constructing Civil Liberties: Discontinuities in the Development of American Constitutional Law*, *Freedom of Speech: Rights and Liberties Under the Law* and *The Supreme Court and American Political Development* (co-eds. with Ronald Kahn). He has also published numerous articles on political, legal, and historical topics in scholarly and intellectual journals. His work has been awarded both the Edward S. Corwin (2000) and the J. David Greenstone Prize (2006) from the American Political Science Association, and APSA's Politics and History section, respectively. He holds a Ph.D. from



Cornell University and a J.D. from Northwestern University.

William Kristol is editor of *The Weekly Standard* and Chairman and co-founder of the Project for the New American Century. Before starting *The Weekly Standard* in 1995, Mr. Kristol led the Project for the Republican Future, where he helped shape the strategy that produced the 1994 Republican congressional victory. Mr. Kristol served as chief of staff to Vice President Dan Quayle during the Bush administration and to Secretary of Education William Bennett under President Reagan. Before coming to Washington he taught politics at the University of Pennsylvania and Harvard's Kennedy School of Government. He has authored and co-edited several books, including: *The Neoconservative Imagination* (with Christopher DeMuth); *Educating the Prince: Essays in Honor of Harvey Mansfield* (with Mark Blitz); *Present Dangers* (with Robert Kagan); *Bush v. Gore: The Court Cases and the Commentary* (with E. J. Dionne, Jr.); and, *The Future is Now: American Confronts the New Genetics* (with Eric Cohen); He is the co-author, with Lawrence Kaplan, of the best-selling book *The War Over Iraq*. He serves on the boards of the Manhattan Institute, the John M. Ashbrook Center for Public Affairs, and the Shalem Foundation. He regularly appears on Fox News Sunday and on the Fox News Channel. He holds a Ph.D. from Harvard University.

John B. Londregan is Professor of Politics and International Affairs at Princeton University. He specializes in comparative politics, Latin American politics and legislative politics. He studies and writes on the



development and application of statistical methods in political science. Professor Londregan has also conducted extensive analysis of Chilean legislative and electoral politics since its transition from the Pinochet dictatorship to democracy. His publications include: *Legislative Institutions and Ideology in Chile* and contributions to numerous journals and edited volumes. He received the Miller Prize for Best Paper in *Political Analysis*, Vol. 8, in 2000.

Harvey C. Mansfield is William R. Kenan, Jr., Professor of Government at Harvard University. His publications include: *Statesmanship and Party Government; A Study of Burke and Bolingbroke; The Spirit of Liberalism; Machiavelli's New Modes and Orders: A Study of the Discourses on Livy; Selected Letters of Edmund Burke* (ed. with an introduction); Machiavelli's *The Prince* (a new translation with introduction; Machiavelli's *Florentine Histories* (with Laura F. Banfield a new translation with introduction); *Taming the Prince; The Ambivalence of Modern Executive Power; America's Constitutional Soul; Machiavelli's Virtue; Niccolò Machiavelli; Discourses on Livy* (with Nathan Tarcov, a new translation with introduction); *A Student's Guide to Political Philosophy; Manliness*; and, Tocqueville's *Democracy in America* (translation, with Delba Winthrop). Professor Mansfield has held Guggenheim and NEH Fellowships and has been a Fellow at the National Humanities Center. He won the Joseph R. Levenson award for his teaching at Harvard, received the Sidney Hook Memorial award from the National Association of Scholars, and in 2004 accepted a National Humanities Medal from the President. He received his Ph.D. from Harvard University.



Wilfred M. McClay holds the Sun Trust Bank Chair of Excellence in Humanities and is Professor of History at the University of Tennessee at Chattanooga. His publications include: *The Masterless: Self and Society in Modern America*, which received the 1995 Merle Curtis Award of the Organization of American Historians for the best book in American; *The Student's Guide to U.S. History*; *Religion Returns to the Public Square: Faith and Policy in America*; and, *Figures in the Carpet: Finding the Human Person in the American Past*. He was awarded fellowships from the National Endowment for the Humanities and the Woodrow Wilson International Center for Scholars, and was designated one of the nation's outstanding educators in the Templeton Honor Rolls for 1997-1998. He is a member of the National Council on the Humanities and is a Senior Scholar at the Woodrow Wilson International Center for Scholars and a Senior Fellow at the Ethics and Public Policy Center. For the spring of 2007, Professor McClay will serve as the Fulbright Professor in American Studies at the University of Rome. He earned his Ph.D. from Johns Hopkins University.

Lawrence M. Mead is Professor of Politics at New York University. He has been a Visiting Fellow at Princeton and at the Hoover Institution at Stanford. His research interests focus on the problems of poverty and welfare in the United States and the politics and implementation of welfare reform. He was a principal exponent of work requirements in welfare, an approach that now dominates national policy. Professor Mead's publications include seven books and numerous articles and other publications on these subjects. *Government Matters*, his study of welfare reform in Wisconsin,



was a co-winner of the 2005 Louis Brownlow Book Award, given by the National Academy of Public Administration. Professor Mead has consulted with federal, state, and local governments in this country and with several foreign countries. He testifies regularly to Congress on poverty, welfare, and social policy, as well as commenting on these subjects in the media. He received his Ph.D. in political science from Harvard University.

Ramesh Ponnuru '95 is a Senior Editor for the National Review, and the author of *The Party of Death: The Democrats, the Media, the Courts, and the Disregard for Human Life*. He has published articles in numerous newspapers including the *New York Times*, the *Washington Post*, the *Wall Street Journal*, the *Financial Times*, *Newsday*, and the *New York Post*. He has also written for *First Things*, *Policy Review*, *The Weekly Standard*, *The New Republic*, and numerous other publications. He is the author of the monograph *The Mystery of Japanese Growth* (American Enterprise Institute/Centre for Policy Studies). He has been a fellow at the Institute of Economic Affairs in London and a media fellow at the Hoover Institution in Stanford. He is a graduate of Princeton University.

Diana J. Schaub is Professor and Chairman of the Department of Political Science at Loyola College in Maryland and a member of the President's Council on Bioethics. She was awarded a postdoctoral fellowship in Harvard University's Program on Constitutional Government and is also a recipient of the Richard M. Weaver Prize for Scholarly Letters. Professor Schaub served



the University of Connecticut, and New York University, and currently, a Visiting Fellow at Nuffield College, Oxford. He has written and lectured on economic and policy development in the United States, Britain and other countries. Dr. Stelzer holds a Ph.D. from Cornell University.

Joseph P. Viteritti is the Blanche Davis Blank Professor of Public Policy at Hunter College, CUNY. In 2003-04, he was a James Madison Program Visiting Fellow and Visiting Professor at Princeton University. His publications include: *Choosing Equality: School Choice, the Constitution; Civil Society* (Brookings Institution Press); and, co-edited with Diane Ravitch, *Making Good Citizens: Education and Civil Society* (Yale University Press). He co-chaired with Diane Ravitch the Program on Education and Civil Society at New York University from 1995 to 2003. Their essay “A New Vision for City Schools” that appeared in *The Public Interest* has been reissued in five scholarly collections. His forthcoming book, *Can Religion and Democracy Co-exist? American Discord from the Public School to the Public Square* will be published by Princeton University Press. Professor Viteritti has written widely in social science journals, law reviews, and popular media such as the *New York Times* and the *Washington Post*. He holds a Ph.D. from the City University of New York.

Murray L. Weidenbaum is Mallinckrodt Distinguished University Professor at Washington University in St. Louis, where he is also Honorary Chairman of the Weidenbaum Center on the Economy, Government, and Public Policy. His research interests focus on economic policy, taxes, government spending, and regulation. He served as President
